CONTROLLING BODY: Male qualifying Royal Victorian Bowls Association
 Female qualifying Victorian Ladies Bowling Association

EVENT: **QUALIFYING EVENT FOR THE AUSTRALIAN OPEN 2010**

DATES: From Monday 8 February to Friday 12 February, 2010

VENUES: Various Clubs in the Bendigo District Bowls Association.

ENTRY CONDITIONS:

Open to all bowlers affiliated with a State or Territory Association, that is affiliated to Bowls Australia or affiliated to an international body that is a member of World Bowls.

- 1. Qualifying events:** Players must enter through the host State/Territory Association by the nominated closing date. Late entries will not be accepted into the event but placed on waiting lists should withdrawals occur. Waiting list will be prioritised based on time entries are received. Once the draw has been published, no late entries will be accepted. Players/teams on a waiting list may only be considered up until 48 hours prior to the commencement of the event to replace a withdrawn player/team only.
- 2. Australian Open:** Bowlers wishing to enter the event must qualify through one of the state based qualifying events or being given direct entry by Bowls Australia.
- 3. Australian Open - Over 60s:** Players in the over 60s triples must enter through Bowls Australia by January 15, 2010. Late entries will not be accepted into the event but placed on waiting lists should withdrawals occur. Waiting list will be prioritised based on time entries are received. Once the draw has been published no late entries will be accepted.
- 4. Australian Open - Under 18:** Each State and Territory Association (STA) is to nominate a maximum of four players (two male, two female). The nominated players must be the preceding STA Junior Singles Representative from the Australian Junior Championships and the preceding State Junior Singles Champion. In the event that it is the same player, the second state nominee would be the State Junior Singles Runner Up.
- 5. AERF Mixed Pairs Challenge:** Bowlers wishing to enter the event must qualify through one of the AERF state based qualifying events. The winner from each state will play in the finals of this event at the Australian Open.
- 6. Australian Open - Athletes with a Disability (AWD) - replacing the Australian Bowls Classic:** Each State and Territory Association (STA) will select representatives from within their state in conjunction with appropriate organisation for persons with a disability. Each state can enter one male and one female per disability category (hearing impaired, visually impaired, wheelchair athletes, and athletes with an intellectual disability), for men's singles, women's singles and mixed pairs. For the inaugural event, STAs are welcome to use players from another state should they not be able to fill their own positions. This must be arranged between the STAs involved.

ELIGIBILITY:

As a condition of entry to compete in a Bowls Australia event, all competitors must:

- (a) not be currently under disqualification or suspension by their state/territory association or their national authority.
- (b) satisfy the eligibility criteria of the member state/territory association;
- (c) comply with all applicable rules and regulations of Bowls Australia and the Bowls Australia anti-doping code.

FORMAT:

All events will be played in sets play as outlined in Law 15 of the Laws of the Sport of Bowls.

- **SINGLES:** Four bowls per player, two sets of nine ends, with a time limit of two(2) hours per match (not including trial ends).
- **PAIRS:** Three bowls per player, two sets of nine ends, with a time limit of two(2) hours and thirty(30) minutes per match (not including trial ends).
- **TRIPLES:** Two bowls per player, two sets of nine ends, with a time limit of two(2) hours and thirty (30) minutes per match (not including trial ends).

Time limits will apply to all games for all disciplines, with the exception of the finals. No time limit will apply for quarter finals, semi finals & final games.

A signal will be given five minutes before the time fixed for starting each session. Any player/team arriving 15 minutes after the starting time shall lose the right to play trial ends. Any player/team arriving at the green more than 30 minutes after the official starting time shall forfeit the game and the points for that game or not progress through to the next round.

Pace of green shall be determined before play on each day by the green keeper and an umpire who shall then post that information in a prominent place at the venue.

1. Qualifying

The format of competition will be conducted by either knockout or sectional play with post sectional knockout play if required. The format of play will be determined by the host controlling body based on the number of entries received in each discipline. The host controlling body will determine the final winners to progress to the Australian Open. The following process will be used to determine the player to progress through to the main draw::

Knockout play

Player(s) or team(s) will be chosen based on the round reached. In the event that one or more players or teams must be selected from a round, players or teams will be ranked based on the criteria outlined in Law 15.3. Only the match where the player was eliminated will be considered. Players or teams will be ranked on:

Sets won

Net set points

Net shots - shots for minus shots against (not including tie breaker ends)

If two or more players or teams are still equal, the above outlined ranking steps will be used for the previous round.

Sectional play

All sectional play will be conducted in accordance with Law 15.3.

In the event that a player or team must be chosen from across multiple sections where post sectional play has not been conducted, the same criteria from Law 15.3 will be used to rank the players or teams. The highest ranked player(s) or team(s) as required will then be chosen.

2. Australian Open

The competition will be conducted in knockout play. The draw size will be:

3. Australian Open – Over 60s

The competition will be conducted in knockout play.

4. Australian Open – Under 18

The competition will be conducted in sectional play format followed by knockout finals. Law 15.3 will be used to determine sectional winners.

5. AERF

The competition will be conducted in sectional play format followed by crossover elimination finals. Law 15.3 will be used to determine sectional winners. Playoff will be conducted for third to eighth place

6. Australian Open - Athletes with a Disability

The competition will be conducted in sectional play, with eight sections of four. Each section will consist of four players from different states with the same disability. The breakdown of which states will play in each section will be randomly assigned after entry numbers have been confirmed. In sectional play each player / team will play each other player / team in their section once. The winner of each section will be determined as outlined in Law 15.3 of the Laws of the Sport of Bowls. A knockout final will be held between the winners of each section in the same disability category. Gold and silver medals will be awarded to the winner and runner up. There will be no overall state award.

TIE-BREAKER:

1. If a game is tied after the two sets have been completed (each player having won one set or both sets having been drawn), a best-of-three-ends tie-breaker should be played to decide the winner.
2. The tie-breaker will be decided by the highest number of shots won in the three ends.
3. There should be no further play in the tie-breaker if, at any point, it becomes impossible for one player or team to draw or win the tie-breaker, given the number of ends left.
4. If the third end of a tie-breaker has been completed and the scores are still level, the players should play a fourth tie-breaker end to decide the winner.
5. If the fourth end of a tie-breaker is a tied end, the players will play further tie-breaker ends until a winner is found.

PROCEDURE FOR APPLYING TIME LIMITS:

- Start of Play – Play will commence with the Tournament Director signalling the start time by a bell, horn, etc.
- End of Play – At the completion of the allocated time, the Tournament Director will signal the end time of play by a bell, horn, etc. At this time players will complete the current end they are playing. (The start of an end is determined by the delivery of the jack by the first player in that end).

- Should the result of the game not be determined by the Laws of the Sport the following principles will be applied:
 - **Sectional Play:** Should a set/tie breaker not be completed as per the Laws of the Sport, then

the score stands as at the completion of the end in play and the player with the highest number of shots for that set/tie breaker will win that set/tie breaker. In the event that the scores are tied then the tie stands and each player receives one point.
 - **Knockout Play:** Should a set/tie breaker not be completed as per the Laws of the Sport, then

the score stands as at the completion of the end in play and the player with the highest number of shots for that set/tie breaker will win the set/tie breaker. If the final scores are tied, then one additional end is to be played to determine a winner.

TRIAL ENDS:

Two trial ends only will be allowed for all games in accordance with Law 18.1.

FOOTWEAR AND ATTIRE:

As per the Laws of the Sport of Bowls, including Domestic Regulation 5. Footwear must adhere to Appendix A2. Attire must adhere to Appendix A3 and the BA logo policy. This policy is available on the Bowls Australia web site www.bowlsaustralia.com.au The new attire policy is effective as of February 1, 2010.

The new compliance rules will be enforced for the Australian Open. Failure to adhere to the BA Logo Policy will result in the offending player being given a verbal warning by the convening match umpire which will be lodged and recorded with the tournament director. The offending player will then be provided up until the forfeit time of their subsequent game to comply with the BA Logo Policy. Failure to comply by this deadline will result in the offending player being disqualified and the game forfeited to their opponent.

STAMP ON BOWLS:

All bowls used during the event must carry a current World Bowls stamp of the current year or later. Random checking of bowls may occur prior to the commencement of games. Bowls Australia's bowls testing policy is available on the Bowls Australia web site www.bowlsaustralia.com.au

Players requiring bowls testing shall be liable for the cost of the test.

ALTERATIONS TO THE FORMAT & LENGTH OF GAMES

- a. The Controlling Body reserves the right to alter the format, times of play and greens to suit local unforeseen circumstances, giving as much notice as practical.
- b. Where a program is interrupted or cannot be completed due to inclement weather or local conditions, the Jury of Appeal may amend the format and length of games to achieve a result or postpone the event where an outcome cannot be achieved.

ARRANGEMENT FOR PRACTICE: See Law 13 of the Laws of the Sport of Bowls

REPLACEMENT / SUBSTITUTE PLAYERS

1. Qualifying

- a. The singles, pairs and triples events shall be played throughout by the competitors whose names appear on the scorecard of the first game. Players may change formations prior to the start of the subsequent game. The Tournament Director must be notified of all changes. Players will be required to complete the relevant paperwork regarding the adjustments made.

- b. A replacement shall be utilised in the following manner:
 1. The team may call upon an affiliated player to replace a pairs or triples team member before the commencement of the event. Substitute players will not be allowed after the team's first match has been started.
 2. Substitute player(s) are not permitted in the singles events.

If the player / team is unable to complete any game already commenced during the competition, then the opponent(s) shall win on forfeit. Points shall be awarded to the winning player/team in accordance with Law 15.3.

2. Australian Open

- a. **Singles** - substitute player(s) are not permitted in the singles events.
- b. **Pairs** – teams must consist of at least one of the team members that competed in the qualifying event. Should a team wish to replace a player, after qualifying, the replacement player must not have entered any pairs qualifying events. Bowls Australia must be notified of the reason for the replacement and the name of the new player. Bowls Australia reserves the right to reject the replacement player.
- c. **Triples** - teams must consist of at least two of the team members that competed in the qualifying event. Bowls Australia must be notified of the reason for the replacement and the name of the new player. Bowls Australia reserves the right to reject the replacement player.
- c. The singles, pairs and triples events shall be played throughout by the competitors whose names appear on the scorecard of the first game. Players may change positions prior to the start of the subsequent game. The Tournament Director must be notified of all changes. Players will be required to complete the relevant paperwork regarding the adjustments made.
- d. Substitute players will not be allowed after the team's first match has been started.

DELAYING PLAY: See Domestic Regulation 14 of the Laws of the Sport of Bowls

RESTRICTING MOVEMENT OF PLAYERS DURING PLAY:

After delivering their first bowl, players will only be allowed to walk up to the head under the following circumstances.

- Singles game
 - the opponents: after delivery of their third and fourth bowls.
- Pairs game (each player playing three bowls)
 - the leads: after delivery of their second & third bowls; and
 - the skips: after delivery of their first, second and third bowls.
- Triples game (each player playing two bowls)
 - the leads: after delivery of their second bowl;
 - the seconds: after delivery of their second bowl; and
 - the skips: after delivery of each of their bowls.

At the start of each end, the lead and second will be at the mat end.

In exceptional and limited circumstances, a skip can ask that a player walks up to the head, or a player to the marker in singles, earlier than described above. If a player does not meet these terms, law 35 will apply.

MARKING TOUCHERS:

In all Bowls Australia events, only "spray chalk" can be used to mark touchers (not in Victorian Qualifying events).

DRUG TESTING:

Bowls Australia's Anti Doping Policy shall apply. See www.bowlsaustralia.com.au for details.

JURY OF APPEAL

A jury of appeal shall be appointed for the purpose of deciding upon any points not provided in the conditions of play, for dealing with any appeals from decisions made by umpires and/or the tournament committee, and generally for the purpose of exercising overall authority on behalf of Bowls Australia.

In the event of an appeal during the playing of the event, such appeals shall be made in accordance with the Laws of the Sport of Bowls, and shall be directed to a Jury of Appeal which shall consist of :-

- (i) Qualifying
 - Host STA President or nominee
 - Host STA CEO or nominee
 - Tournament Chairman/Director
 - Chairman of Umpires or rules committee

- (ii) Australian Open
 - BA President
 - BA CEO
 - Tournament Director
 - National Officiating Director

PRIZE MONEY:

Qualifying: No prize money has been allocated for any qualifying event unless associated with another event.

Australian Open: Prize money of \$120,000 will be available for the event. Distribution of the prize money will be as allocated on the Bowls Australia web site – www.bowlsaustralia.com.au.

OTHER LAWS, REGULATIONS & POLICIES

All other Laws, Regulations & Policies other than stated above shall conform to the Laws of the Sport of Bowls and Domestic Regulations for Australia, as published in September 2006 (reprinted May 2009) including amendments (located at www.bowlsaustralia.com.au)

The Bowls Australia Extreme Weather and Smoking Policies will apply to the entire event.



Australian Open Qualifying

Advancement To Main Draw

Singles (60 qualifiers required)

Because the number of Sections being played exceeds the number of qualifiers required, one round of knockout play needs to be completed. This round will commence at approximately 4.00pm on Monday February 8, 2010 at the same venues that hosted Sectional Play.

See "Subsequent Play" for the draw.

Triples (30 qualifiers required)

Because the number of Sections being played is less than the number of qualifiers required ALL Section winners will advance to the main draw. Consolation winners based on a ranking of all teams other than the Section winners will take the remaining places available in the main draw. Teams that qualify as consolation winners will be advised to Bowls Australia and the successful contestants that afternoon.

Pairs (31 qualifiers required)

Because the number of Sections being played exceeds the number of qualifiers required, one round of knockout play needs to be completed. This round will commence at approximately 5.30pm on Thursday February 11, 2010 at the same venues that hosted Sectional Play.
