

2021/22 Pennant Permit Request Form



This form must be completed for an Affiliated Member who wishes to represent a Club other than their Nominated Club in a Bowls Victoria Pennant competition; i.e. two Metropolitan Clubs, two Country Clubs or one Metropolitan and one Country Club.

Permission to play Pennant for two different Clubs must be submitted to BV for the Pennant Permit to be issued. All Pennant Permits EXPIRE on 30 June each year, irrespective of when issued. Application must be made for a new Permit prior to playing Pennant for your non nominated Club.

An affiliated member of Bowls Victoria may play in a Midweek (Monday – Friday) or Weekend Pennant Competition for a Member Club other than the Member's Nominated Club, provided both clubs sign the applicants BV Pennant Permit Request Form.

An additional permit will be required for each Pennant Competition you wish to play in outside of your nominated Club.

All permits must be applied for and issued prior to Round 5 of the respective Pennant Season.

NO permits will be issued after Round 5 of the respective competition. Once a Permit is issued that player must play out the whole season and is not permitted to revert to playing for their Nominated Club during that season. If a player applies for and is granted a Clearance from their Nominated Club throughout the duration of the Permit, it automatically expires, and a new Permit will not be issued after Round 5.

A player with a Pennant Permit may not play in the Singles, Pairs, Mixed Pairs, Triples and Fours State Championships of Victoria on behalf of their Permit Club. Playing in other club-based events is at the discretion of the Club or the controlling body.

SECTION 1 needs to be completed by the Secretary of the Member's Nominated Club & forwarded to the Secretary of the Pennant Permit Club to complete SECTION 2.

The completed form is to be forwarded to Bowls Victoria each season for approval. The Club where the Permit is being sought to will be invoiced the relevant \$20 fee. **Please allow a minimum of five working days for requests to be approved.**

NOTE:1. This Pennant Permit Request Form is not effective until notification from Bowls Victoria is received by the requesting Club in Section 1 by email.
